- 7) That the records /accounts shall be furnished to.
- 8) That the list of governing body shall be furnished to the D.E.O. every year.
- 9) That the pay stricter /fee stretcher fixed by the governing body shall be got approved by the D.E.O. every year.
- 10) That all the conditions prescribed in the G.O.s and other orders which are not specified in this orders shall be completed with.
- 11) That the schools shall not be closed without giving notice both to the parents /D.E.O and competent authority at least 6 months before.
- 12) That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
- 13) That the society shall submit proposed for renewal of provisional recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the renewal.
- 14) The society should renew the fire certificate every year well in advance without fail.

- 07 That the records / accounts shall be furnished to the District Educational Officer, every year by 30th September at least.
- 08 That the list of Governing Body shall be furnished to the District Educational Officer every year.
- 09 That the pay structure / fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
- 10 That all the conditions prescribed in the G.O.'s and other orders which are not specified in this order shall be complied with.
- 11 That the school shall not be closed without giving notice both to the parents / District Educational Officer and competent authority at least six months before
- 12 That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
- 13 That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., At least six months prior to the date of expire of the present recognition.
- 14 That the society shall provide fire safety measures in the school as per the No Objection Certificate.
- 15 The management informed that no thatched roof accommodation is allowed to run the School.
- 16 Proper and adequate Toilets / sanitation facility shall be provided for students especially for girl students.
- 17 Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
- 18 The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments.
- 19 The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
- 20 The school shall have first aid kit and the teachers shall be trained in first aid.
- 21 The Correspondent of the concerned school is hereby informed to file an affidavit to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.
- 22 That the management shall obtain and submit the structural soundness certificate every year before reopening of the school for the academic year to the Inspecting Officer concerned without fail.
- 23 That the management shall ensure the Accountants of this school audited by an authorized Chartered Accountant every year and submit.
- 24 That the management has to maintain trained teachers at all time.
- 25 The management is informed to follow the guidelines issued in G.O.Ms.No.91 Education, Dated.06.08.2009 regarding Fee Structure in Private Schools.
- 26 That the Management of the school is informed to obtain the Occupancy Clearance from the Fire Service Department concerned for the entire period of recognition.
- 27 The Correspondent of the concerned school is hereby informed to file an affidavit before April 30th of every year to the effect that there is no deviation or violation of norms prescribed by the Government from time to time
- 28 That the Management of the school is informed that, to obtain the Occupancy Clearance from the Fire Services Department concerned for the entire recognition period from time to time and shall submit the same to this office without fail.
- 29 That the Management of the school is informed to obtain the Structural Soundness Certificate issued by the Executive Engineer, R&B / Panchayat Raj for the entire recognition period from time to time and shall submit the same to this office without fail.
- 30 **That the management of the school in informed that, to renew the register leased deed in the name of educational society. Soon after receipt of the registered leased deed in the name of the educational society the remaining period will be granted as per rules in force.**
The District Educational Officer, Krishna is requested to issue instructions to the Correspondent of the school and to obtain the above documents shown at above point number 28 to 29 from time to time and to submit to this office for taking further course of action.
